## If a child chooses to disclose information relating to their safety, you SHOULD:

- Be respectful, accessible and receptive
  listen carefully and uncritically at the child's pace.
- Take what is said seriously—reassure the child that they are right to tell
- Tell the child that you must pass this information on
- Make a careful record of what was said
- Tell the DSL (or Deputy DLS) without delay

### You should NEVER:

- Take photographs of injuries or examine marks/injuries beyond giving first aid
- Investigate or probe by asking leading questions
- Jump to conclusions or react with shock, anger or horror
- Confront another person (adult or child) allegedly involved
- Offer opinions about what is being said or about people allegedly involved
- Ask a child to sign a written copy of the disclosure or a "statement"

# Safeguarding at Bexton Primary School

#### Welcome to Bexton Primary School.

We hope that your visit is an enjoyable and inspiring experience and that you will join us in our vigilant awareness of the safety and wellbeing of our pupils. We recognise that **safeguarding is everyone's responsibility** and we value your engagement with the children in our care.

### **Child Protection**

All visitors must sign in at Reception. At Bexton we take our responsibilities for child protection very seriously and whilst we hope that you are made to feel welcome by our staff and pupils, **please ensure that your identification sticker is visible at all times.** 

All visitors must also sign out at Reception.

Please do not use your mobile phone at all in nursery or reception, or record, or photograph any of the children without the express permission of the Head Teacher.

In line with current safeguarding recommendations, we request that frequent visitors to the school complete our volunteer registration form and work with us to obtain enhanced DBS clearance.

Always have identification documents available for staff to check.

Our shared responsibility is to safeguard and promote the welfare of children. This includes:

- Protecting children from maltreatment
- Preventing impairment of children's health or development
- Ensuring that children have safe and effective care
- Taking action to support children where necessary

If you suspect that a child or young person is being abused or neglected or is at risk of serious harm, you should contact the DSL or Deputy DSL (details overleaf). Please be mindful of the possibility of all kinds of abuse: physical, emotional, sexual and peeron-peer abuse, as well as neglect.

If you have specific concerns about a member of staff or receive an allegation against yourself, please inform the head teacher, Mrs Emily Armstrong.
